Owner agrees that any granting of space and/or service is purely for a specific term as agreed above and there is no guarantee of anything beyond that term. No slip, mooring or space may be subleased and Noank Shipyard, Inc. retains the right to utilize a boat owner's slip or mooring when vacant.

Owner agrees that neither he/she, nor his/her family, guests, agents or invitees will use yard equipment and hereby agrees to hold the yard, its officers, employees and agents harmless against any and all claims for damages or injuries by any of them.

Without assuming responsibility owners, managers and/or assigned employees are expressly given permission to board any boat while at Noank Shipyard/Seaport Marine in order to protect said craft, the docks or the property of other boat owners. Owner agrees that any and all expense due to loss or damage to the boat or its equipment.

Owner further agrees to abide by all rules, regulations, safety and environmental procedures as set forth in writing and/or on signage by Noank Shipyard, Inc. at either of it's locations. Failure to abide by any and all of Noank Shipyard, Inc. policies and procedures may void this agreement and result in forfeiture of all fees regardless of stated refund policies.
